

# Fixed Deposit Account Number on Money Market Confirmation

## **PURPOSE**

This document illustrates the steps to show fixed deposit account number on money market placement or rollover confirmation letters.

## **WHY IS THIS IMPORTANT?**

Some bank practices required to show fixed deposit account number in the money market placement or rollover confirmation letters.

## **SET UP FIXED DEPOSIT ACCOUNT AT COUNTERPARTY SSI**

Create fixed deposit account at Set Up > Static > Settlement Instructions > Counterparty SSI. Click [here](#) for more details on Counterparty SSI set up.

Maintain the fixed deposit account information at the “Acct Ref” field.
